General Conditions of Rental Camping du Pouldu

(Textes en vigueur au 24 Novembre 2018)

RENTAL:

 The booking is taken into account upon receipt of a check or payment CB validated, representing 25% of the amount of the stay, plus 15 € fee file (Free internet).

It does not become definitive until we receive a confirmation from us payment of the balance of the stay.

- ${f \cdot}$ The balance must be paid 30 days before the beginning of the stay without call from us, otherwise we reserve the right to consider your registration canceled and to apply the flat-rate cancellation compensation provided below. For bookings less than 30 days before the start date the stay, full payment is required at the time of booking
- The rental is personal. It is prohibited to sublet or assign the location to a third party.
- Tents, Canadian or Igloo are not allowed on the pitches rental, mobile homes, coco sweet.
- The number of occupants can not be greater than the indicated capacity of location. Duly authorized visitors are placed under the responsibility of the tenant during their stay.
- No refunds will be given for early departure for any reason.
- The tenant is responsible for the equipment and equipment rented. An inventory of places is made from each tenant, the tenant is obliged to control it the day of his arrival and to signal any anomaly. The cleaning of the rental is the responsibility of the occupant.
- Two security deposit checks (not cashed) of € 250 and € 50 are deposited at the arrival. They are returned the day of departure, if the places and materials are returned compliance with the inventory. Any breakage, deterioration or loss will be charged and retained on the amount of the deposit according to repair bill. If any cleaning costs proved necessary, the check of 50 € would be kept.
- The starting inventories take place on Saturdays from 8.30am to 11am. In case of early departure or outside the opening hours of the reception desk, the deposits will be returned by mail to the tenant after inspection of the premises.
- The renter must notify the management of any expected delays upon arrival. The reservation would be canceled if the management was without news 24 hours after the arrival date.
- The tenant must provide compulsory insurance of his civil liability.
- We inform you that according to Article L121-21-8 of the Consumer Code, you do not have a 14-day cooling-off period the online booking of your stay.
- In the event of cancellation by the camper, the following deductions will be made: -More than 30 days before the scheduled date, the deposit only will be refunded -Between 21 and 30 days 50% of the cost of the stay -Between 8 and 20 days75% of the cost of the stay -Less than 2 daysThe entire stay is due.
- •In case of cancellation due to Camping du Pouldu, except in case of force majeure, the stay will be totally refunded. This cancellation can not however not give rise to the payment of damages.

CAMPING PITCH:

- Royalties are established according to the fixed price principle. This daily package includes: a pitch for a tent or a caravan, a vehicle, access to the toilet blocks, access to the swimming pool and animations. A second tent of the igloo or Canadian type for 2 places is allowed on the same site without extra charge.
- Only minors accompanied by a direct line parent are accepted.
- · Maximum 6 people per location.
- The booking is recommended for the months of July and August. It becomes definitive only after receipt of a payment of 25% of the amount of the stay.
- Payment of the stay: it is done at the reception desk on the day of arrival, its amount is established according to the tariff indicated and the number of nights counted from 14h to 12h.

The pitches must be released at 12h, failing one day additional fee will be charged.

- The stay is due until the date indicated at the time of registration or reservation. A copy of the identity card will be required as a deposit.
- In case of cancellation by the camper, more than 30 days before the date of arrival.
- In case of cancellation due to Camping du Pouldu, except in case of force majeure, the stay will be totally refunded. This cancellation can not however not give rise to the payment of damages.
- ANIMALS: Dogs in categories 1 and 2 are prohibited. Animals of + 10kg are prohibited in the locatives. They must be tattooed and vaccinated, they must be kept on a leash permanently. Their owners will pay special attention to prevent or clean any soil. Access to sanitary facilities, swimming pools, playgrounds is forbidden to them.
- SWIMMING POOL: Shorts or bermudas are not allowed in the pool, slip or boxer of obligatory bath.
- VISITORS and GUESTS: Their comings must be requested each time at the office Home. Visitors are required to pay a fee at the indicated rate, but in no case have access to the pool.

INTERNAL REGULATIONS Camping du Pouldu

1 - CONDITIONS OF ADMISSION AND STAY
To be allowed to enter, settle and stay on the camp-site, it must be authorized by the manager or his representative.
It has the obligation to ensure the good behavior and order of the campsite and compliance with the application of these rules.
Staying means accepting the rules and the commitment to comply with them. No one can choose to live there.
Any infringement, misrepresentation or fraudulent use of the access card may lead to formal notice.

2-POLICE FORMALITIES

Minors unaccompanied by their parents will only be admitted with written authorization from them.

In application of Article R. 611-35 of the code of entry and stay of foreigners and asylum, the manager is required to have the the client of foreign nationality, as soon as he arrives, an individual police file. It must mention in particular:

1*The name and first names;

2. The date and place of birth;

3* nationality.

3° nationality;
4. The habitual residence.
Children under the age of 15 may appear on the card of one of the parents.

3 - INSTALLATION
The vehicle, tent or caravan must be installed at the location indicated in accordance with the instructions.
Order and cleanliness must be kept around.
Users must respect the boundaries of the site and leave the unoccupied sites completely free.

4 - RECEPTION DESK
In season: open from 9h to 12h30 and from 14h to 19h every day.
In the reception desk you will find all the information on the services of the campground, the information on the possibilities of refueling, sports facilities, the tourist wealth of the area and various addresses that may be useful.
A system for collecting and processing complaints is available to customers.

5 - PAYMENT OF STAY

It is done 30 days before arrival or at the reception desk on the day of arrival depending on the type of accommodation. The amount is based on the rate and the number of nights from noon to noon.

The pitches must be released at 12h. Otherwise an extra day will be charged. The stay is due until the date of departure indicated during registration or reservation.

The authorization of admission must be requested each time at the reception desk by their hosts who are responsible for it. If these visitors are allowed to penetrate in the camper who receives them may be required to pay a fee to the extent that the visitor has access to campground the camper who receives them may be required to pay a fee to the extent that the visitor has access to campground facilities. This fee is posted at the entrance of the campground and at the reception desk.

Under no circumstances can the vehicle of guests and visitors enter the campsite. Visitors can not enter before the opening and

after the closing of the reception desk. Minor visitors unaccompanied by their parents will only be admitted with written authorization from them

Visitors do not have access to the pool.

If they have not completed this formality, the persons who will receive them will be taxed on the number of persons not declared since the beginning of their stay.

7 - ANIMAI S

Less than 10 kg allowed.
They must be tattooed and vaccinated. They are admitted only after approval of the Direction.
They must be kept on a leash permanently and remain under the constant supervision of their masters. They can not in any case be alone or tied.
Their owners will take special care to prevent or clean any soil. Access sanitary, swimming pool, plain of games and businesses is forbidden to them.

8 - CIRCULATION AND PARKING OF VEHICLES

Only vehicles belonging to campers staying in the campground may be driven in the campground. These must mark the stop when leaving and to ride in step. Parking must not interfere with traffic or prevent new arrivals Drivers must ensure that the speed limit of 10Km / h is respected

9 - SILENCE AND NOISE

Vehicle traffic is prohibited inside the pitch from 10:30 pm to 07:30 am. Users must avoid any noise, games or discussions that could annoy the All sound devices must always be set to minimum. Closures of doors and chests should be as discreet as possible.

The silence must be total from 10 pm to 7.30 am

10 - KEEPING AND APPEARANCE OF THE INSTALL ATION

10 - KEPING AND APPEARANCE OF THE INSTALLATION Everyone must ensure the good appearance of its installation and the cleanliness of its location. This one will be left in its initial state and cleaned during the departure. It is not permitted to delimit the location of an installation by personal means, nor to dig the ground. Linen drying is forbidden from trees. The washing of the linen and the crockery must be carried out only in the bins provided for this purpose. All common facilities must be left clean after each use. Household waste prepackaged in airtight bags must be properly placed in garbage cans or containers. The cardboards, crates and bulky packages should be placed empty next to the containers. The parents will have to accompany the young children to the toilets and to make sure that they do not play in the toilets. Any damage to vegetation, fences, land or facilities will be the responsibility of the author.

11-GAMES Children should always be under the supervision of parents who are criminally and civilly responsible for their children when using the games The apparatus and gantries must not be diverted from their normal use. No violent or embarrassing games can be organized near the facilities They are prohibited from 10:00 pm to 9:00 am.

12 - SECURITY

Users retain responsibility for their facilities and take all precautions to safeguard their property and must report to the responsible for the presence of any suspicious person. The Branch is responsible for the items deposited in the Office and has a general obligation to monitor the campsite.

Wood fires, embers or volcanic stones are strictly forbidden on the sites.

Collective barbecues are available to users. Charcoal is the only fuel allowed.

Stoves must be kept in good working order. The electrical installation of the fixed equipment must comply with the manufacturer's specifications. Defective installations may be disconnected and any intervention may give rise to compensation.

In case of fire, notify the management immediately. Fire extinguishers may be used when necessary.

A first aid kit is located at the reception desk.

No person with a contagious disease can stay in the establishment.

13 - DISPLAY
These rules of procedure are posted at the entrance of the campground and at the reception desk. It is given to each client who requests it.
For classified campgrounds, the classification category with the mention tourism or recreation and the number of tourism or recreation sites are displayed.
The prices of the various services are communicated to the customers under the conditions fixed by order of the Minister in charge of the consumption and searchable at the reception.

14 - DEAD GARAGE (1) AND TELEPHONE (2)
(1) Unoccupied equipment may only be left on a site after the agreement of the management and only at the location indicated.
Management is not responsible for this material in the absence of the owner. A fee whose amount is displayed will be due for the dead garage.
(2) This is reserved for urgent calls. The telephoned messages are posted at the reception.

15 - INFRINGEMENT OF RULES OF PROCEDURE
In the case where a resident disturbs the stay of the other users or does not respect the provisions of the present rules of procedure,
the manager or his representative may, orally or in writing if he deems it necessary, give notice to the latter to cease the disturbances.
In the event of a serious or repeated infraction of the rules of procedure and after formal notice by the manager to comply with them, the latter may terminate the contract.
In the event of a criminal offense, the manager may appeal to the police.

16 - THE MANAGER OR HIS REPRESENTATIVE. He is responsible for the order and the good keeping of the ground. It has the duty to sanction serious breaches of the rules
